Foreword

Promoting populations' health is an enterprise whose complex and often subtle dimensions challenge scholars and practitioners from diverse disciplines. Epidemiologists, social scientists, educators, policy scientists, economists, urban planners and biomedical scientists (most recently including geneticists) all contribute perspectives that illuminate one aspect or another of health promotion. Each discipline also offers an evaluation scheme appropriate to its strategic focus. It is easy to understand how casual observers may be frustrated in their search for a single, clear analysis to answer the bottom-line question of just how effective health promotion is. As the authors represented in this book attest, the answer very much depends on what aspect of the health promotion initiative is being addressed. Of course, matters of theoretical justification, intervention strategy, adequacy of resources and other issues of quality—the process questions—pertain, but at the end of the day the results should be measured in ways that are consistent with the stated objectives. Who benefits and how, and who is missed and why, are the central evaluation questions.

The genius of this collection of evaluation approaches to diverse health promotion programmes and related policies is what it reveals about the spread of options: options that do not compete but supplement each other. For the builder of a health promotion strategy, the task is to discover the available evaluative technology with the best fit, and to apply it in a way that balances a comprehensive view with a necessary parsimony of effort. Cost–effectiveness must apply to evaluation design as well as programme design.

For organized health promotion efforts to be positioned as key resources in pursuing social and economic goals, there must be evidence of their effectiveness and their relative costs as compared with other health promoting options: for example, approaches targeting reductions in individual risk versus those seeking reductions in risk conditions through policy change.

The requirement for evidence-based health promotion pertains to public health practice in general, from designing an intervention through evaluating its impact. Criteria for such evidence are expanding to include negative impact as well as positive benefits and a wide range of effects on community wellbeing and economic and social development goals.

Until the publication of this book, it was difficult to juxtapose the myriad dimensions of health promotion, the spread of their assumptions and theories, the challenges faced in planning and undertaking evaluations of health promotion initiatives, and the basis for choosing an approach to evaluation. Further, it is now easier to appreciate the value-added potential of combining several measures focused, for example, on personal, community, environmental and political impact. The chapters of this book demonstrate the conundrum that the whole may be greater than the sum of its parts.

As health promotion comes of age as a theory-informed, evidence-based and broadly accountable practice, this book provides a landscape of evalua-

tive issues and options that can help refocus health promotion planning before resources are committed. It is much more than a catalogue of evaluation methods. Implicit in each chapter is a closely argued rationale for the design or choice of a given intervention, a rationale that helps clarify the potential limitations of the method, and the necessity of having a systems-based strategy for promoting the health of populations and individuals. The principal benefit of this book for health promotion practitioners is a sense of how disparate kinds of technology can join together as complementary parts of a strategic whole.

This book – with two shorter companion documents aimed at practitioners and policy-makers – is a major link in a series of developments aimed at strengthening the capacity of national and local resources to broaden the health promoting impact of both programmes and policies. With more powerful evaluation tools, used with greater specificity to pursue diverse objectives, health promotion efforts can be more equitable, more empowering, more participatory, more accountable and more sustainable.

She uses behavioural and community research methodologies to contribute to understanding how communities work, and promotes health strategies to improve the health of people living in Kansas. Dr Lewis has expertise in community organizing and development, and programme development and evaluation. Her research interests include: self-help groups, minority health, disadvantaged populations and issues in adolescent health, such as pregnancy, violence, substance abuse and HIV/AIDS.

Nicole Lezin is President of Cole Communications in Santa Cruz, California, United States. She has a degree in public policy and management from the Yale School of Organization and Management. She designs and manages applied research communication and health policy studies. Ms Lezin has extensive experience in developing and conducting large-scale programme and policy evaluations in a number of public health areas, including HIV/AIDS prevention, injury control, tobacco control and child health.

Christine M. Lopez is a former doctoral student in the Human Development and Family Life Department and was a research associate for the Work Group on Health Promotion and Community Development of the University of Kansas, United States. Ms Lopez is interested in community-based research in the areas of substance abuse, violence by young people and health promotion in rural settings.

David V. McQueen is a Senior Biomedical Research Scientist and Associate Director for Global Health Promotion at the National Center for Chronic Disease Prevention and Health Promotion at CDC, United States. Before this, he had been Director of the Division of Adult and Community Health and Acting

Director of the Office of Surveillance and Analysis at the National Center for Chronic Disease Prevention and Health Promotion. Before joining CDC, he was Professor and Director of the Research Unit in Health and Behavioural Change at the University of Edinburgh, United Kingdom (1983–1992) and, prior to that, Associate Professor of Behavioral Sciences at the Johns Hopkins University School of Hygiene and Public Health in Baltimore. He has served as director of WHO collaborating centres and as a technical consultant with the World Bank.

Nancy Milio, Ph.D., is Professor of Health Policy and Administration at the School of Public Health and Professor of Nursing at the University of North Carolina at Chapel Hill, United States. Her teaching, research and publications centre on policy development and implementation, strategic analysis and evaluation in public health services; food and nutrition; community information technology; and health promotion/education. She has worked with numerous governments (in Scandinavia, eastern and western Europe, Australasia and Latin America), and with WHO and the Pan American Health Organization as policy analyst and consultant for 20 years. Among her publications are 8 books and over 100 articles in 40 health, social science and policy journals in 7 countries. She has been visiting professor at universities in Australia, Brazil, Colombia, Finland, the Netherlands, New Zealand, Spain and the United Kingdom, as well as in the United States. Her most recent book is *Public health in the market: facing managed care, lean government, and health disparities* (Ann Arbor, MI, University of Michigan Press, 2000).

Adrienne Paine-Andrews is Associate Director of the Work Group on Health Promotion and Community Development and Assistant Research Professor of the Schiefelbusch Institute for Life Span Studies at the University of Kansas, United States. She also serves as the programme co-director for the initiative for the prevention of adolescent pregnancy sponsored by the Kansas Health Foundation. She is primarily interested in research that promotes community health and development, and works to empower marginal groups. She conducts collaborative research with a variety of groups, including members of community health initiatives. She is currently involved in several research projects in the areas of health promotion, community development and adolescent health. She is co-author of several articles on self-help, community development, adolescent pregnancy and substance abuse prevention, and health promotion.

Richard Parish is Chief Executive of the Health Development Agency, United Kingdom. Before this appointment, he was Regional Director of Education and Training for Eastern England.

Louise Potvin is Professor of Community Health in the Department of Social and Preventive Medicine, University of Montreal, Canada. She currently holds

a Chair/Mentorship from the Canadian Foundation of Health Services Research on community approaches and health inequalities. Her main area of research is the evaluation of community health promotion programmes.

Dennis Raphael received his Ph.D. in educational theory from the Ontario Institute for Studies in Education, University of Toronto, Canada, previously earning a B.Sc. in psychology from Brooklyn College and an M.Sc. in psychology from the State University of New York, Cortland. He is an Associate Professor of Public Health Sciences and a former Associate Director of the Masters of Health Science Program in Health Promotion at the University of Toronto. Dr Raphael is co-director of the Quality of Life Research Unit at the University's Centre for Health Promotion. His areas of expertise are in research methodology and design, quality-of-life research, and the design and evaluation of health promotion activities. Dr Raphael has developed qualityof-life instrumentation for elderly people, adolescents and people with developmental disabilities. He has completed a study of the quality of life of two communities in Metropolitan Toronto and, most recently, a national project, funded by Health Canada, designed to improve the quality of life of older Canadians; information and reports on it are available on the Internet (http:// www.utoronto.ca/qol, accessed 9 January 2001).

Pamela Ratner is Assistant Director of the Institute of Health Promotion Research and Associate Professor in the School of Nursing at the University of British Columbia, Canada. Her postdoctoral work, supervised by Dr Lawrence Green, was supported by the Medical Research Council of Canada and the Killam Foundation. She is currently a Health Research Scholar of the Canadian Institutes of Health Research. Her primary research interests are the social and behavioural determinants of health and health promotion. Specific projects have addressed the epidemiology of violence and intentional injury, efforts towards tobacco control and smoking cessation, risk perception and communication, and community participation in health care planning.

Lucie Richard is Assistant Professor, Faculty of Nursing, University of Montreal, Canada. She is currently a Career Award Researcher of the Medical Research Council of Canada. Her main area of research is the professional practice of health promotion practitioners and the theoretical underpinnings of health promotion programmes.

Kimber P. Richter, M.P.H., Ph.D., is a Research Assistant Professor in the Department of Preventive Medicine at Kansas University Medical Center, United States. She is also a faculty fellow in the Center's School of Nursing faculty development programme in substance abuse, funded by the Center for Substance Abuse Prevention of the Substance Abuse and Mental Health Services Administration of the US Department of Health and Human Services. A former doctoral student and member of the Work Group on Health Promotion and

Community Development at the University of Kansas, Dr Richter's current work focuses on developing effective smoking cessation interventions that are tailored to the needs of people in treatment for chemical dependence. Her publications span topics in bioethics, cardiovascular risk reduction, the prevention/ treatment of drug addiction, methodologies used include clinical trials, participatory action research, qualitative research and ecological measurement.

Irving Rootman is Director of the Centre for Health Promotion and Professor in the Department of Public Health Sciences at the University of Toronto, Canada. Before joining the University in 1990, he held a number of positions in Health Canada, including Chief of the Health Promotion Studies Unit in the Health Promotion Directorate, where he was responsible for managing evaluations of health promotion initiatives and for the development of Canada's national health promotion survey. He has been a senior scientist, consultant and technical adviser for WHO, and is currently director of a WHO collaborating centre in health promotion.

Stergios Russos is a research associate of the Work Group on Health Promotion and Community Development and a doctoral student at the Department of Human Development of the University of Kansas, United States. He completed his Masters degree in public health with an emphasis on health promotion at the Graduate School of Public Health at San Diego State University. His research targets clinical and community-based disease prevention and health promotion in areas including cardiovascular diseases, substance abuse, adolescent development and food security. He is author and co-author of several research and conceptual papers in public health and preventive medicine. His work emphasizes understanding and improving how community-based interventions influence population-level health and development outcomes.

Alfred Rütten is Director of the Research Centre for Regional Health Promotion and Professor of Sports Science and Applied Sociology at the Technical University of Chemnitz, Germany. Jerry Schultz is Associate Director of the Work Group on Health Promotion and Community Development and Adjunct Assistant Professor in the Preventive Medicine, Anthropology and Human Development departments at the University of Kansas, United States. Dr Schultz received his Ph.D. in anthropology from the University of Kansas and has taught there and at the University of Nebraska. He is currently directing a rural health promotion initiative in

Kansas and engaged in developing an electronic technical assistance system for health promotion and community development. His primary interest is research in community development, the empowerment of at-risk community groups and participatory action research. Dr Schultz is co-author of several research articles on health promotion and the evaluation of community partnerships. He is a co-author of several manuals for community development in the areas of the strategic planning and evaluation of prevention initiatives. He has been a consultant for a variety of organizations, including private foundations and community coalitions.

Jane Springett is Professor of Health Promotion and Public Health at Liverpool John Moores University, United Kingdom, where she is also Director of the Institute for Health, which publishes the Journal of contemporary health. She is actively involved in the development of local healthy public policy, having been a member of the joint public health team that developed the Liverpool City Health Plan. She has a Ph.D. in urban geography, and a longstanding research interest in healthy cities and communities. She is currently a member of the local evaluation team for the new Merseyside Health Action Zone, and involved in the evaluation of the Manchester Salford and Trafford Health Action Zone. Her main research interests are joint work and organizational change, participatory evaluation and action research in a variety of settings. She has considerable experience in curriculum development in health promotion, grounded in a theoretical understanding of the way people learn, and currently teaches in the programme for the M.Sc. in health (promotion, research and policy change) and leads the doctoral programme in that area at Liverpool John Moores University

Sylvie Stachenko is Head, Noncommunicable Diseases and Mental Health in the WHO Regional Office for Europe. Prior to joining WHO in 1997, she held a number of positions in Health Canada, including Director of Preventive Services Division, where she was responsible for the development of national initiatives in heart health, diabetes, and breast and cervical cancer. She was also the Director for the WHO countrywide integrated noncommunicable disease intervention (CINDI) programme in Canada and of the WHO Collaborating Centre in Policy Development in Non-communicable Disease Prevention.

Sarah Stewart-Brown is Reader in Health Services Research in the Department of Public Health at the University of Oxford, United Kingdom. She is also Director of the Health Services Research Unit. Before coming to Oxford, she worked in the National Health Service, first as a paediatrician and subsequently as a public health doctor in London, Bristol and Worcester. She has also held academic appointments at the departments of Child Health and of Epidemiology and Community Health at the University of Bristol. Her past research has been in two fields: community child health and health promotion. Her current research interests centre around the importance of emotional well-

being for the health of both adults and children. Her recent publications cover the public health implications of parenting programmes, the ethics of childhood screening programmes and the importance of emotional wellbeing for health in adulthood.
